MESSAGE FROM THE PRESIDENT



Thank you for being an impactful member of the Women's Bar Association Foundation community, helping it to advance its critical mission of funding nonprofits that serve the legal and related needs of women or girls in the DC metro area. I am privileged to share with you how, with your generous support and that of other Foundation donors and contributors, we have advanced its mission this past year.

The Foundation started this past bar year with its 22nd annual Wine Tasting and Silent Auction. This event is the Foundation's premier fundraiser, with the proceeds going primarily towards funding the grants awarded by the Foundation. The celebratory theme for the 2024 Wine Tasting was "C'est Le Vin: An Evening of French Wines." Kirkland & Ellis, LLP graciously provided

the enchanting venue, including its lovely outdoor patio with its DC skyline gazing view, and mother nature provided the perfect weather to take advantage of it! All of that, along with the delicious French wines and amazing auction items made it a night to remember!

In addition to funding community grants through the Wine Tasting proceeds, the Foundation also funds its annual Founders Fellowship. This fellowship, which rotates among DC's six law schools, allows a law student to work with local legal service providers on projects that benefit women or girls in our community. Our 2024 Founders Fellow was Calypso Moschochoritis, a Catholic University Law School student. Ms. Moschochoritis interned for Foundation grantee Ayuda and focused on immigration law. During the Wine Tasting, she shared with us the important work she undertook, and how it inspired her as a person and future lawyer.

In March this year, we held our annual Grants Awards Ceremony—our reason for being—generously hosted by Hogan Lovells. During this year's ceremony, the Foundation awarded \$75,000 in grants to nine grantee organizations: Amara Legal Center, DC Kincare Alliance, DC Volunteer Lawyers Project, First Shift Justice Project, Georgetown University Health Justice Alliance, The Human Trafficking Legal Center, Mother's Outreach Network, The Safe Sisters Circle, and Volare (formerly Network of Victim Recovery DC). With these awards, possible only with the support of our generous sponsors and donors, the Foundation's cumulative total funds given to the community exceeded \$1.3 million!

These local organizations supported by the Foundation provide a wide range of critical legal and support services for at-risk women and children. Examples include providing legal services for survivors of domestic abuse, helping women in low-income jobs secure basic employment rights, and helping survivors of sex trafficking. These organizations provide crucial services that not only improve the lives of countless individuals in the DC metropolitan community but also our community at large.

GRANTMAKING PROGRAM AND GRANTEE AWARDS CEREMONY

The first step in our grantmaking process is a request for Letters of Inquiry (LOI). The Foundation received 22 LOIs in August 2025, requesting a total of \$218,425 in support. The Foundation's Grants Committee reviewed the information in each submission and invited 15 of the organizations to submit a full grant application.

The Grants Committee carefully reviewed each proposal received, made a recommendation to the full Board of Directors to fund a total of \$75,000 in grants to 9 organizations (information about the projects funded can be found on pages X to X). Grantees are required to submit a final report of activities conducted under each grant. These reports are also reviewed by the Grants Committee.



Our 2025 Grant Awards Ceremony was held on March 12, at the offices of Hogan Lovells. Over 100 were in attendance, including supporters, Foundation and Association leaders, grantees, and sponsors.

Grant checks were presented to this year's nine grantees. Representatives from each organization were in attendance and were able to network with others to talk about their work and volunteer opportunities within their organizations.

The evening included the presentation of the 2025 WBAF Champion Award to **Gaffar Chowdhury**, **CAP®**. In his remarks, Gaffar discussed the impact his Foundation service has had on him professionally and personally. "The seven years I served on the Foundation board were some of the most formative of my career. I saw firsthand how directing financial resources with purpose could transform lives for women and girls," he said. "That experience didn't just deepen my commitment to this organization; it helped shape my professional path. It led me to pursue my Chartered Advisor in Philanthropy (CAP®) designation so that I could help others align their financial planning with their values—creating impact in ways that benefit both donors and causes."

He also noted that, "Personally, it also reinforced my belief in leading by example. The Foundation is a part of our family's annual giving and my own estate plan because I want to ensure that this work continues for generations continued on next page...



to come. I encourage everyone here to consider how charitable planning can be a part of their legacy."

A highlight of the evening was hearing from our keynote speaker, **Alexandra Bailey**, an activist and advocate for domestic violence survivors all over the country. Alexandra helped pass the first national legislation to allow for the resentencing of criminalized survivors. Alexandra shared her personal story of domestic violence and the steps she took, with the help of her family, friends, and the staff at Foundation grantee Volare, to escape the abusive situation in which she found herself. She credited Volare's law firm partners with providing the pro bono support and legal expertise she needed to change her circumstances.

Selflessly, she has been paying it forward through her advocacy on behalf of other survivors, especially those who have been incarcerated for defending themselves against their abusers. She helped pass the first national legislation to allow for the resentencing of criminalized survivors. Additionally, her accomplishments include working as a Campaign Strategist and National Organizing Specialist for the ACLU and as a Coordinator for the Women's March in Chicago. She has used her organizing skills to win campaigns including voting rights for unhoused citizens and the passage of the Equal Rights Amendment in Illinois.

2025 GRANTEES

The WBA Foundation grants program supports community nonprofit organizations in the DC metropolitan area that serve the legal and related needs of women and girls in the DC Metropolitan community. The Foundation's grant recipients reach and serve some of the most vulnerable members of our community, individuals who are facing challenges ranging from homelessness to domestic violence and workplace discrimination.



AMARA LEGAL CENTER provides free legal services to survivors of sex trafficking and those who have been harmed by the commercial sex industry, whether involvement was by coercion, necessity, choice, or otherwise, in the DC metropolitan area. Amara's attorneys are trained in providing trauma-informed legal services and are devoted to providing comprehensive support, making sure that its clients know they are not navigating their cases alone. The WBAF grant will support survivors of sex trafficking with legal services, including civil protection orders, child custody, divorce, sealing and vacating criminal records, and victim-witness advocacy.



DC KINCARE ALLIANCE supports the legal, financial, and related service needs of relative caregivers, the majority of whom are women, who step up to raise children in their extended families in times of crisis when the children's parents are not able to care for them. DC KinCare Alliance is the only organization in DC focused solely on serving relative caregivers raising DC's at-risk children. The WBAF grant will support PROJECT ADOPT, which represents relative caregivers trying to adopt the children they raise, and provides legal help to relative caregivers to obtain the rights, benefits, and services needed to ensure a safe and stable home for children whose parents can no longer care for them.



The **DC VOLUNTEER LAWYERS PROJECT** addresses the critical shortage of legal assistance for low-income people in Washington, DC, especially in cases involving domestic violence. The WBAF grant will support the Domestic Violence Program, which provides comprehensive trauma-informed legal, advocacy, and support services to low-income survivors of domestic violence and other forms of gender-based violence, focusing on Wards 5, 7 & 8.



FIRST SHIFT JUSTICE PROJECT empowers workers to exercise their workplace rights. They represent clients whose rights have been violated. Through partnerships with medical clinics and nonprofits, they educate health care providers about the legal rights of caregivers in the workplace so they can better support their patients at work. The WBAF grant will support efforts to empower pregnant and caregiving workers in low wage jobs to exercise their rights related to caregiving and parenting.



GEORGETOWN UNIVERSITY HEALTH JUSTICE ALLIANCE believes that an equitable society, where everyone has the opportunity to thrive and contribute to an integrated and supportive community, requires fair access to health and justice resources. They use law as a tool to improve individual health and wellbeing, transform the systems used to deliver healthcare, and advance Georgetown's broader goals for health, justice, and racial equity. The WBAF grant will support the Perinatal Legal Assistance & Wellbeing (P-LAW) Project to address the health-harming legal needs of pregnant and postpartum patients receiving care at MedStar Washington Hospital Center's Division of Women's and Infants Services.



The **HUMAN TRAFFICKING LEGAL CENTER** connects trafficking survivors with probono representation so they can seek justice and thrive. They demand accountability from traffickers, from governments, and from corporations. The WBAF grant will support the Diplomatic Trafficking Program, which is dedicated to combating the trafficking of domestic workers by diplomats and employees of international organizations.



MOTHER'S OUTREACH NETWORK facilitates the power of Black mothers subject to systems of disempowerment, such as the family regulation and foster system, to upend a socio-economic structure that inadequately addresses their full potential for economic independence. It advances economic security for women and families through social justice education, mutual aid, grassroots mobilization, and legal advocacy, focused on disadvantaged Black women in Washington, DC. The WBAF grant supports efforts to empower Black mothers currently involved in, and at-risk for, their children's involvement in the child welfare system, with support to achieve economic independence, security, and mobility, and equip them with the skills necessary to navigate DC's complex legal, criminal, and foster care systems.



The **SAFE SISTERS CIRCLE** provides free culturally-specific, trauma-informed, and legal holistic services to Black women survivors of domestic violence and/or sexual abuse. Rooted in Safe Sisters Circle is the belief that there is value in having an organization established for Black women and where the majority of service providers and leadership within the organization are also Black women. The WBAF grant will support the Community Lawyer Initiative, which is on-site legal services and traveling legal clinics that provide legal representation to Black women survivors of domestic and sexual violence living primarily in Wards 7 and 8.



VOLARE (formerly Network of Victim Recovery DC) creates equitable healing and dignified experiences for survivors of crime by providing free, trauma-informed advocacy, therapeutic, and legal services in conjunction with strategic litigation, policy advocacy, and education to transform existing responses to harm. The WBAF grant will support DV LEAP, a leader in survivor appellate advocacy; attorneys challenge unjust trial outcomes by litigating appeals, filing Amicus briefs, and fighting for survivor rights all the way to the Supreme Court.

FOUNDERS FELLOWSHIP



The WBA Foundation Founders Fellowship was established in 2006 and is awarded annually to one of the six law schools located in Washington, DC. The fellowship is used by the school to support a student who is pursuing a public interest summer internship to advance the legal interests of women and children.

The 2024 WBA Foundation Founders Fellowship, in the amount of \$5,000, was awarded to the Columbus School of Law (Catholic University), which selected **Calypso Moschochoritis** as the recipient. Ms. Moschochoritis was an Immigration Legal Intern at Ayuda, which provides legal, social, and language services to help low-income immigrants access justice. Fellows are required to provide an essay about their experience. Ms. Moschochoritis said:

"Working at Ayuda has been one of the most rewarding professional experiences I have had. As an immigrant myself, I have always been passionate about the topic of immigration, and interning at Ayuda solidified my commitment to pursuing a career in this field. While I was initially intimidated because I did not have a deep understanding of the legal technicalities of immigration, I quickly realized that I could apply much of what I had learned in my first year of law school to the job. At Ayuda, I had the privilege of working with an incredible team of legal professionals and immigration advocates. With the guidance and support of my supervisors, I was able to navigate the complexities of immigration cases and gain practical experience on the job. Each day presented new challenges, but with their help, I became more confident in my ability to assist clients. I was entrusted with projects involving asylum applications, U and T visas, and Special Immigrant Juvenile Status (SIJS) petitions. It was a rewarding experience that expanded my skills and reinforced my commitment to helping vulnerable communities.

Working at Ayuda was emotionally taxing. The horrors my clients experienced in their home countries, and what some continued to endure in the United States, were unthinkable. I had to learn how to compartmentalize my emotions so that I would not carry the weight of their stories home with me. My supervisors were an incredible resource in this respect. They taught me that it is only human to feel those emotions and that, with time and reflection, I would be able to empower my clients without emotionally burdening myself."

WBAF CHAMPION



The WBA Foundation Board of Directors created the WBA Foundation Champion Award in 2022. The purpose of the award is to recognize a devoted WBA Foundation champion. The 2024 recipient of the award was **Gaffar Chowdhury, CAP**®.

Gaffar is a dedicated supporter of the Foundation whose unfaltering devotion to its mission has manifested in multiple ways over many years. Gaffar served on the WBAF Board from 2013 – 2020. During his tenure, he was engaged on the Finance, Nominations and Strategy Planning committees and served as the Foundation's Treasurer for 2 years. While serving, he freely offered and used his financial expertise to help guide the Foundation and nurture its fiscal responsibility. He also graciously opened his home multiple times to host the Foundation's donor appreciation events.

In addition to being an actively engaged and impactful board leader, Gaffar, repeatedly and generously has sponsored the Wine Tasting and Grant Awards Ceremony! His stalwart support of the Foundation also is reflected in the fact that he is a founding member of the WBAF's Legacy Circle, having committed to the WBAF in his estate planning, helping to ensure the long-term financial well-being of the Foundation.

While his monetary support is critical, of equal importance is the selfless donation of his precious free time and valuable professional services to the Foundation's Silent Auction. In particular, he has repeatedly donated to be auctioned off a popular weekend outing on his boat on the Potomac, in which he takes the winner and several guests on a scenic summer afternoon/evening wine and cheese cruise on the river. He also has donated his professional financial planning services, through his company, District Wealth Strategies, including, without hesitation, in response to an open call to Foundation supporters for additional auction items.

Gaffar, often joined by his wife, Brooke, makes it a priority to attend Foundation events, reliably there, in person, to mingle and engage at all of its fundraisers. But it doesn't end there -- Gaffar enthusiastically uses his voice on public platforms to champion the Foundation. Specifically, he is an active and unrelenting promoter of the Foundation on social media, raising the Foundation's profile and promoting its mission, across his expansive professional and personal network.

Gaffar is the President & CEO of District Wealth Strategies, a financial planning firm, and currently serves on the Women's Bar Association's Wellbeing Committee, on the D.C. Bar's Board of Governors, and as the Immediate Past President of the National Association of Insurance and Financial Advisors - Greater Washington D.C.

ONLINE CAMPAIGNS

The Foundation participated in two online giving campaigns this past year: Giving Tuesday and Springtime Support. The campaigns were promoted through social media and board member outreach to their personal networks.



Giving Tuesday is held the Tuesday after Thanksgiving. It's a day when people are encouraged to do good and give generously. The December 3, 2024 fundraiser raised over \$4,100, from 13 donors; a small increase from the prior year.



We launched our spring fundraiser at the Annual Dinner on May 22, and invited donors to support us in a 24-hour giving blitz through May 23. The result was over \$2,700 raised from 24 donors, an increase over prior spring fundraisers.

PLANNED GIVING

To effectively pursue the WBA Foundation's mission of meeting the legal needs of women and girls in the DC area, we must ensure the Foundation's long-term financial vitality. Gifts to the Foundation that cost nothing during your lifetime can be made as part of the legacy you leave behind. Options include:

- Name the WBA Foundation as a beneficiary of an existing life insurance policy, a retirement or investment account, or a charitable annuity;
- Establish a bequest through your will or trust;
- Establish a charitable trust that supports the WBA Foundation and your loved ones.

The growth of the Foundation's endowment depends primarily on gifts from bequests. An attorney or financial planner can help to identify other ways to support the WBA Foundation and provide tax savings while possibly leaving more assets to heirs.
